Glenwood's Downtown Market moved to 7th Street between Cooper and Colorado in 2020. This new venue allowed us to social distance while maintaining the spirit of a small town atmosphere.

Market Eligibility

GROWER ELIGIBILITY REQUIREMENTS:

All fresh produce and agricultural products must be Colorado-grown. Vendor resale is 40% of your product unless your offering does not duplicate another vendor's product (i.e. fresh milk, eggs, cheese, vegetables, meat products); at which point it may be 100% resale. Prices must be competitive and in line with other vendors. Underselling will not be tolerated.

ARTISAN ELIGIBILITY REQUIREMENTS:

All art must maintain the sense of an outdoor market (nothing mass-produced). Vendors will be juried to maintain the highest quality and limit duplication of product. Artisans may choose a 5 week mini season or a full 15 week season; however, full season vendors have preference.

GOURMET/HOT FOOD VENDORS:

Food must be prepared in a commercial, State Health Department approved kitchen and then reheated to serve at the market or sold in preserved form. Vendors must comply with all Public Health Regulations pertaining to their product. Download applicable forms at glenwoodmarket.com

SPECIAL EVENT TAX LICENSE

All vendors are required to have a Special Event Sales Tax License. We recommend purchasing your license after you have been accepted. You can download the application at colorado.gov or at glenwoodmarket.com. A copy must be present in your booth.

Complete and return this application for the full season or the 1st mini season by **May 18th, 2021**. Applications will be accepted after this date and throughout the season based on availability. Glenwood's Downtown Market is loyal to returning vendors.
